What we are about

The Purfleet Trust is a charity based in King's Lynn providing support to individuals who are homeless or at risk of becoming homeless in West Norfolk. We achieve our objectives through effective working partnerships, enabling us to deliver activities and services designed to tackle the causes of homelessness and reduce the risk of repeat homelessness.

What we provide

A day centre provides access to hot food, showers, laundry services and the numerous other small things that many of us are able to take for granted.

- A safe, warm and welcoming space for homeless vulnerable people
- Access to housing advice, support with specific issues, education and training
- Training houses to help build the skills and confidence needed to live independently. We deliver a tenancy training programme covering all aspects of managing a home and individuals rights and responsibilities as a tenant and a neighbour.
- Training courses such as 'Cooking on a Budget', 'Hospitality', 'Basic Food Hygiene' and 'First Aid'

What your donation can do

Due to the generosity of local retailers and people we work with, your donations can:

- Feed a single homeless person for two weeks for £10
- Fund a tutor to deliver an 'employability' workshop for up to 6 people for £20
- Buy clothes, haircuts and help towards transport costs for an interview for £30
- Buy a 'move on' pack for moving in to a person's home for £40

What is Gift Aid?
